DECISION ON PROCLAMATION OF THE CONSTITUTIONAL LAW FOR IMPLEMENTATION OF AMENDMENT OF XXXIII XXXVI TO THE CONSTITUTION OF THE REPUBLIC MACEDONIA

Proclaimed Constitutional Law for the implementation of amendments XXXIII to XXXVI of the Constitution, the Parliament at its session held on 11 January 2019.

Constitutional law enforcement amendments XXXIII to XXXVI the Constitution enters into force with the entry into force of the amendments XXXIII, XXXIV, XXXV and XXXVI of the Constitution.

CONSTITUTIONAL LAW FOR IMPLEMENTATION OF AMENDMENT TO BY XXXIII XXXVI of the Constitution

Article 1

Amendments from XXXIII to XXXVI of the Constitution come into force with the entry into force of the final agreement to resolve the differences described in resolutions 817 (1993) and 845 (1993) of the Security Council of the United Nations, for annulment of the Interim Accord of 1995 and the establishment of strategic partnership between the parties and the ratification of the Protocol of accession to NATO of the first part of the final agreement.

Amendments from XXXIII to XXXVI of the Constitution have no legal effect, do not enter into force and void immediately if the conditions set out in paragraph 1 of this Article.

Article 2

The provisions of Amendment XXXIII regulations and other acts of state bodies shall apply from the date of entry into force of this law.

From the date of entry into force of the Amendment XXXIII, citizenship will be Macedonian / citizen of the Republic of Northern Macedonia, which determines neither predetermines the ethnicity of citizens.

Citizenship, Macedonian / citizen of the Republic of Northern Macedonia in identity documents and passports of citizens being written in Macedonian language and its Cyrillic alphabet. Citizenship, Macedonian / citizen of the Republic of Northern Macedonia in identity documents and travel documents of citizens speaking

official language other than Macedonian and its Cyrillic alphabet, written in Macedonian language and its alphabet in that language and its alphabet and will be determined in that language in all laws which shall be applied.

From the date of entry into force of the Amendment XXXIII, use of the word in relation to the state, state bodies and public institutions in relation to other uses under the final agreement in accordance with its name or by its abbreviated name to read "the Republic of North Macedonia "or" Northern Macedonia ".

Article 3

Existing official documents and materials of public administration for international use and documents for internal use which can be used outside the country, shall comply with Amendment XXXIII within five years of their assigned duty entry into force.

Article 4

Compliance Amendment XXXIII of existing documents and materials intended exclusively for internal use will begin with the opening of each chapter of the relevant box in the negotiations with the European Union, and will end no later than five years from the opening of the chapter.

Article 5

Regarding the implementation of Amendment XXXV country's sovereignty, territorial integrity and political independence of neighboring countries: Albania, Bulgaria, Greece, the Republic of Kosovo and Serbia.

Article 6

This constitutional law for implementation of amendments XXXIII to XXXVI of the Constitution declares the Parliament and enters into force on the date of entry into force of the constitutional amendments.
